

Job Title: Tree Maintenance Officer

**Grade:** Grade 6

Section: Neighbourhoods (Community Safety)

Reports to: Arboricultural Team Leader

### The Job

#### Is to:

- carry out all aspects of tree maintenance in relation to BS 3998, which will include crown thinning, crown lifting, felling and general tree management as well as BS 8545 tree planting and management of new trees to ensure that WDH trees remain in a safe and healthy condition;
- work both from the ground and climb at height within the tree canopy using specialised equipment in order to maintain WDH trees to a safe and healthy condition;
- carry out all works to a high quality standard and play a lead role in the management of a safe on-site environment to ensure that personal, colleague and public safety is protected at all times;
- be responsible for carrying out tree maintenance in accordance with legislation especially in relation to working on or close to the highway; and
- respond to emergency situations on WDH estates involving risk posed by trees including out of office hours and weekend work as required.

## **The Bigger Picture**

#### You will:

- support the delivery of a high quality, flexible and continually improving arboricultural service as part of an integrated landscape management service;
- take the lead role in supervising the work of a dedicated small team when carrying out arboricultural operations across a range of sites and be a positive role model to other members of your team to ensure that work operations are carried out according to specification, required timescales and with due regard to health and safety and all other relevant legislation and standards.
- carry out any other duties as directed by the line manager that is appropriate to the grade and overall purpose of the job, and
- provide relief cover for WDH Landscape Officers to maintain safe and clean environmental conditions as and when required.

### The Day to Day

#### You will:

- climb trees using a recognised and approved method, and use equipment specifically
  designed to safely work throughout the canopy, which may include the use of ladders to
  gain access to work areas within tree canopies when required;
- prune and safely remove branches from within the canopy, remove poor branch formation to aid tree health in line with British Standards in a safe and competent manner;
- use equipment such as power saws and or hand saws to safely work on the ground or within the tree, and use methods which may include the use of lowering equipment and or rigging systems when dismantling trees in a safe and competent manner;
- Oversee and take responsibility for a safe on-site working environment to ensure personal, colleague and public safety is protected at all times;
- Ensure that all lowering equipment is regularly checked and assessed in relation to Lifting Operations and Lifting Regulations (LOLER);
- operate shredding and chipping equipment to safely dispose of woody material such as branches and shrub growth;
- clear sites, residential areas and surrounding grounds of woody and herbaceous materials such as tree stumps, brush and limbs leaving such sites in immaculate condition after works completed;
- fell trees that have been pre-assessed and identified as requiring removal in a safe manner that gives utmost consideration to the health and safety of surrounding areas, property and potential risk posed to people;
- use and maintain suitable site traffic and public access safety signage in association with local tree work to ensure public health and safety is protected at all times;
- ensure that all tools and equipment remain in a safe working condition at all times and ensure that full compliance with maintenance and inspection schedule is managed;
- provide excellent customer service at all times and engage with members of the public, external agencies and WDH teams in a way that positively promotes the WDH Landscape service and organisation as a whole:
- provide information to the public regarding trees and their safe care in a manner that promotes excellent customer service;
- carry out estate based environmental maintenance work as required in order to support the wider WDH landscape service;
- help implement any estate based environmental initiatives in agreement with area estate management teams to positively contribute to the upkeep of WDH neighbourhoods; and
- undertake a range of duties and training sessions involving the safe use of various power tools, mechanical equipment and the use of WDH vehicles as appropriate to the tasks required. All use will be in full accordance with the appropriate Health and Safety Regulations.
